Symptoms	Cough, shortness of breath, temperature >100 F, chills, muscle or body aches, headache, sore throat, congestion, runny nose, fatigue, loss of taste or smell, diarrhea, nausea, or vomiting. The Westview School encourages all eligible students, faculty and staff, and visitors to be vaccinated if they are able. To be considered fully vaccinated for the purposes of these protocols processes, two weeks must have passed since the final dose of the vaccine and students and employees must confirm their COVID-19 vaccination records with the school.
